# Admission principles

1<sup>st</sup> International School of Ostrava - mezinárodní gymnázium, s.r.o (the School) is a school registered under the Ministry of Education, Youth and Sport of the Czech Republic. Therefore the School follows all national legislative procedures and requirements in its admission process. School Law (Act 561/2004) describes in detail all procedures.

The School offers an 8-year education programme (Grade 6 - Grade 13) with continuous preparation for the IB DP study in Grade 12A and Grade 13A. The programme is based on the Czech national curriculum, and it is combined with the DP requirements and elements of the particular subjects and areas. This School Educational Programme was approved by the Czech Ministry of Education, Youth, and Sport; and it serves as the official curriculum of the school. The students are prepared for and take the final examination both from the IB DP and the Czech system. Passing the Czech system Maturita exam serves as the official high school diploma of the Czech Republic.

The School also offers a 4-year educational programme (Grade 10B - Grade 13B) which follows the Czech curriculum, as well as a different School Educational Programme. The programme is focused on the Maturita exam only as the official exit examination.

All applicants take entrance exams. Those applying for Grade 6 and Grade 10 must take the national standardised tests in the Czech language and Maths, as well as the School English exam, to determine the level of English of the applicants. All applicants must pass all three parts of the Entrance Exams to be accepted. These exams take place in April in accordance with the Ministry Resolution.

Applicants to grades other than Grade 6 and 10 take the Entrance Exams from English and Maths. These tests provide basic skills and knowledge diagnostics of the applicants and help the School prepare for various support future students may need during both their personal and educational development.

All applicants are informed about the option to study the IB DP in Grade 12A and Grade 13A. We also organise regular meetings with students and their parents in Grades 9A and 11A to inform them properly about their options, including, when appropriate, informing them about the Admission Policy for entering the Diploma Programme.



# The IB Diploma Programme

# **Choice of programme**

- Having considered the test results, the academic school counsellor and the IB coordinator will recommend an appropriate programme for each student. Students may be admitted to the full Diploma programme or advised to follow a Certificate programme that is tailored to their needs and abilities. The IB Programme can also be combined with the final Czech Maturita school examination.

#### **Candidates**

- a) Internal students refer to students who are enrolled in Grade 11A at the school.
- b) External students refer to students who are enrolled in different schools.

### **Admission process**

In order to be accepted to the IBDP programme, candidates are recommended to have achieved the following:

- a) The passing mark for each subject is specified below:
  - i) English Placement Test at least 76 %
  - ii) MFL (German, French, Spanish) Placement Test at least 76 %
  - iii) Mathematics Skills at least 33 %

#### **Entrance requirements**

- a) English test (B1-B2)
  - i) Part 1: Writing on a given topic
  - ii) Part 2: Language test
- b) Mathematics Skills
  - i) Mathematical techniques, including applying mathematical techniques to solve problems. Contents are:
    - 1) Number systems and set notation
    - 2) Algebraic simplifications
    - 3) Factorization
    - 4) Product expansion
    - 5) Surds and radicals
    - 6) Scientific notations
    - 7) Linear equations and inequalities
    - 8) Adding and subtracting algebraic fractions
    - 9) Formula rearrangement
    - 10) Pythagoras' theorem
    - 11) Coordinate geometry
    - 12) Right-angled triangle trigonometry
- c) MFL (German, French, Spanish) Languages (Level A2-B1)
  - i) Part 1: Grammar test
  - ii) Part 2: Essay on a prescribed topic
- d) Interview
  - i) The School may also request that the student attend an interview. This is an opportunity for the student to present his/her educational background and explain any inconsistency in test results or to demonstrate language proficiency. Students are expected to present themselves and their extra activities in the form of an interview.



#### **Exclusion**

Candidates with language certificates DELE (A2), Goethe Institute (A2), DELF (A2) and DALF (A2), Cambridge (B2 First) will not have to take the English and the MFL tests.

#### Time and venue of entrance tests

- a) Internal students
  - i) The school will accept applications beginning on the 31<sup>st</sup> of March for admission in the following academic year.
  - ii) The date of the test will be set by the Head of the School.
- b) External students
  - i) Applications will be accepted individually by the Head of the School.
  - ii) The IB DP programme will be introduced by the IB coordinator.
  - iii) The date of the test will be set individually by the Head of the School.

# Regulation of subject selection in the IB Diploma Programme

### **Subject Selection**

- The school offers subjects for the IB Diploma Programme, and the school will try to meet student needs. Due to scheduling, however, some students may be asked to choose a different subject.

#### **Core components**

- The three core requirements of the IBDP Creativity, Action, Service (CAS), Theory of Knowledge (TOK), and Extended Essay (EE) are compulsory for students following the full Diploma Programme and the Certificate track of the programme. Students following the full Diploma Programme can earn up to 3 extra marks for successful completion of TOK and EE.

#### Self-taught mother tongue

- The 1<sup>st</sup> International School of Ostrava - mezinárodní gymnázium appreciates the variety of languages spoken by the school community. Advice and support are given to students whose mother tongues are other than the currently offered Language A, and who want to include their mother tongue in their subjects programme. The school will assist parents in searching for suitable teachers, and it offers internal training to the latter.

#### Students transferring from other IB Schools

- The 1<sup>st</sup> International School of Ostrava - mezinárodní gymnázium accepts students who started the IBDP at other IB schools on condition that the school currently offers the subjects they studied in their previous school. Transferring students are exempt from entrance tests. However, the transferring student needs to submit reports and/or a letter from their previous school confirming that he/she was enrolled in the IB Diploma Programme. Students who wish to carry over any Internal Assessment tasks from their previous school need all required IB forms completed and signed by their supervisors.
